Patritti has a variety of spaces suitable for sit down or stand-up cocktail-style functions and events. The availability of these areas is limited due to licensing considerations – Unfortunately these spaces are not available on Friday afternoons and evenings, Saturdays and Sundays (10-5pm).

- The Courtyard provides a combination of seats, wine barrels and standing area for up to 200 guests. Most of the courtyard is unsheltered, with the use of market umbrellas & existing trees to provide shade and coverage.
- Our Cellar II space can cater for up to 20 guests seated.
- The Warehouse offers a smaller, undercover area for up to 80 guests standing or 50 guests seated. This space is perfect for cocktail parties or long table tastings, meetings & smaller indoor gatherings.

Terms and Conditions

Confirmation & Deposit

Prepayment of the venue hire fee is required to confirm a booking and must be made within 7 days of the original tentative booking. Payment of a deposit AND completion of a booking form must accompany this confirmation. Management reserves the right to cancel the booking and allocate the venue to another client if this confirmation is not received.

Payment & final numbers

Are required 5 working days prior to the event. This number will represent the minimum numbers for which you will be charged. Final accounts must be settled on or before the night, Payment on the night is accepted with cash or credit card only. Personal cheques are not accepted. By signing this document, the organiser authorises Patritti to charge their card for any shortfall in the minimum spend requirements.

Cancellations

In case of a cancellation, Patritti will refund the deposit if the cancellation is made a minimum of 14 days prior to the function date.

Price

Please note that prices and products are subject to availability and change and may alter without notification. However, they are firm from payment of a deposit for 2 months.

Menu

Details must be finalised at least 7 days prior to the function so our caterer can assure the quality and availability of food.

Compliance

It is understood that the organiser will conduct the function in an orderly manner in full compliance with Patritti's regulations and Liquor Licensing Laws. The Management reserves the right to exclude or eject any objectionable persons from the premises without liability.

Responsible service of alcohol

Patritti practices responsible service of alcohol on all occasions. Intoxicated persons will not be allowed to enter the estate and will be refused alcohol service. Guests under 18 years of age are not permitted to consume alcohol on-site.

Responsibility

Organisers are financially responsible for any damage/ breakages sustained to Patritti by the organiser, organisers guests, invitees or other persons attending the function. Patritti will not accept any responsibility for the damage or loss of merchandise left prior to or after the function.

Venue hire fee is required as deposit. No weddings/ ceremonies or wakes. Cleaning deposit of \$1,000 required for birthdays under 24 years.

Displays of signage

Nothing is to be nailed, screwed, or adhered to any surface or part of the building.

BYO cakes

We are happy for event organisers to provide a cake, disposable plates & cutlery (if desired) for your function.

No other food or beverage is to be brought in and consumed in the function without prior notification to Patritti Management.

Courtyard bookings and weather

All courtyard bookings are made at the organisers risk. In case of poor weather, Management will attempt to relocate courtyard bookings subject to availability. Patritti are bound by Liquor Licensing Laws which may prevent such a relocation. Patritti reserves the right to cancel the event if environmental circumstances are beyond our control.
